**CERTIFICATE OF LOCATION**  
Lode Mining Claim

NOTICE IS HEREBY GIVEN that **Redstar Gold USA, Inc.**,  
**3775 Heavenly Valley Lane, Reno, Nevada 89509**, hereby claims under and  
pursuant to the laws of the State of Nevada and of the laws of the United  
States of America the following described LODGE MINING CLAIM:

The name of the claim is the DRY 41  
This claim was located on October 6, 2005, by posting a Location Notice at the discovery  
monument found at, on, or near the South end of the claim.

The length of the claim is 1495 feet in a North direction and 5 feet in the opposite  
direction from the monument where the Location Notice is posted, and the width is 300 feet on each side of  
the center of the vein or lode, comprising in all 1500 feet in length and 600 feet in width, and generally  
following a North-South course.

The exterior boundaries are distinctly marked by four substantial monuments. Each corner monument  
consists of a 2" x 2" x 4 wooden post with aluminum tags attached, scribed with claim name and corner description,  
set one foot in the ground. The boundaries can be readily traced by beginning at corner No. 1, the  
Northwest corner:

thence 600 feet East to the NE corner, corner No. 2,  
thence 1500 feet South to the SE corner, corner No. 3,  
thence 600 feet West to the SW corner, corner No. 4,  
thence 1500 feet North to the NW corner, corner No. 1, the point of beginning.
