JURISDICTION AND VENUE

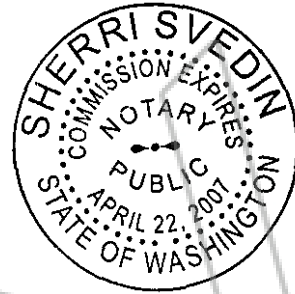

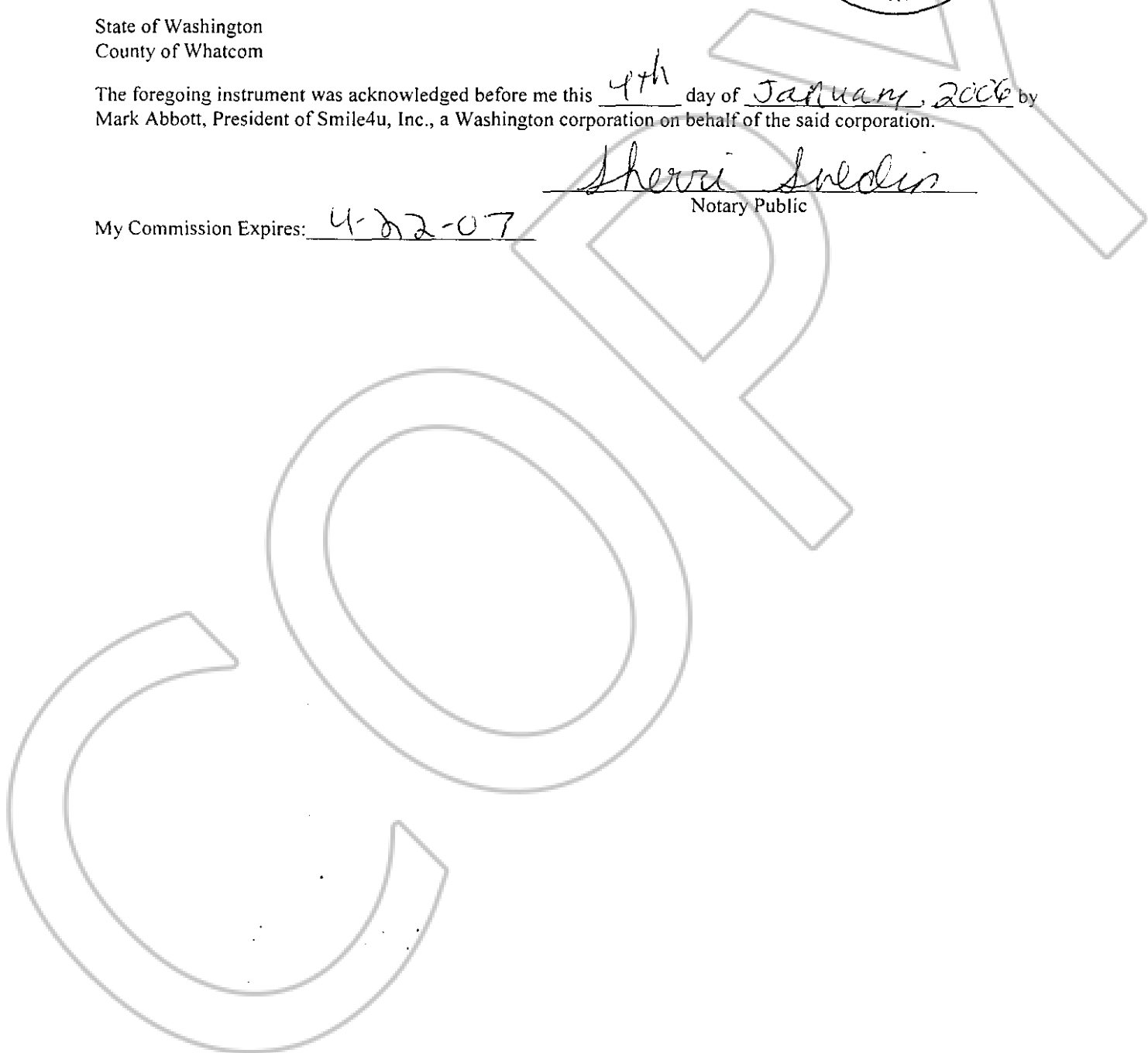
