CERTIFICATE OF LOCATION

Lode Mining Claim

NOTICE IS HEREBY GIVEN that Barrick Gold Exploration Inc., 293 Spruce Road, Elko, Nevada 89801, hereby claims under and pursuant to the laws of the State of Nevada and of the laws of the United States of America the following described LODE MINING CLAIM:

The name of the claim is the BC 92.

This claim was located on November 14, 2005, by posting a Notice of Location at the discovery monument found at, on, or near the center of the claim.

The length of the claim is 750 feet in a WEST direction and 750 feet in the opposite direction from the monument where the Notice of Location is posted, and the width is 300 feet on each side of the center of the vein or lode, comprising in all 1500 feet in length and 600 feet in width, and generally following an EAST-WEST course.

The exterior boundaries are distinctly marked by four substantial monuments. Each corner monument consists of a 1-1/2" x 1-1/2" x 4 wooden post with aluminum tags attached, scribed with claim name and corner description, set one foot in the ground. The boundaries can be readily traced by beginning at corner No. 1, the Northwest corner:

thence 1500 feet east to the NE corner, corner No. 2,
thence 600 feet south to the SE corner, corner No. 3,
thence 1500 feet west to the SW corner, corner No. 4,
thence 600 feet north to the NW corner, corner No. 1, the point of beginning.

The Northwest corner of this claim, corner No. 1, is found about 479 feet NORTH and 100 feet WEST from the W1/4 corner of section 15 Township 36N., Range 49E., M.D.M.

Said claim is located in the:

NE 1/4 of section 16, T.36N., R.49E.

SE 1/4 of section 16, T.36N., R.49E.

NW 1/4 of section 15, T.36N., R.49E.

SW 1/4 of section 15, T.36N., R.49E.
