1480 feet is claimed in a **N 60 degrees W (Az. 300 degrees)** direction and
20 feet in a **S 60 degrees E (Az. 120 degrees)** direction from the point of discovery
(monument of location), at which the Notice of Location was posted, together with **300**
feet on each side of the monument of location and centerline of the claim. The general
