**MINING DEED**

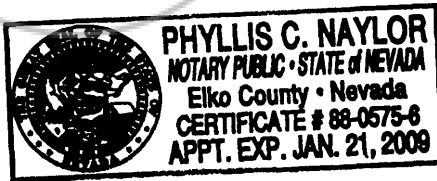
