The undersigned corporation hereby certifies that it has located the **NCAR 69** lode mining claim in Section(s) 20, 29, Township 36 North, Range 51 East, Mount Diablo Base and Meridian, in the unknown Mining District, County of Eureka, State of Nevada.

The claim is 1500 feet in length and 600 feet in width, and 1490 feet is claimed in a East direction and 10 feet is claimed in a West direction from the location monument upon which the Notice of Location is posted, together with 300 feet on each side of the center of the claim. The general course of the lode deposit and premises is from the West to the East
