

No. 4: Northwest Corner	NW Corner <u><b>ROD 43R</b></u>	2" X 2" X 4' wood post

As erected on the ground, each corner monument is marked as described above by a scribed metal tag.  
 The work of location consisted of making a claim map as provided in N.R.S. 517.040 which map is  
 recorded herewith.
