The claim is approximately 1500 feet long and 600 feet wide, such that 20 feet are claimed in a easterly direction and 1480 feet in a westerly direction from the point of discovery (monument of location), at which the Notice of Location was posted, together with 300 feet on each side of the monument of location and center line of the claim. The general course of the lode or vein is from the easterly to the westerly direction.



| No. 3: Southwest Corner | SW Corner <u>ROD 47R</u> | 2" X 2" X 4' wood post |
| No. 4: Northwest Corner | NW Corner <u>ROD 47R</u> | 2" X 2" X 4' wood post |

As erected on the ground, each corner monument is marked as described above by a scribed metal tag. The work of location consisted of making a claim map as provided in N.R.S. 517.040 which map is recorded herewith.
