The general course of the lode or vein is from the easterly to the westerly direction.



No. 3: Southwest Corner	WC 220' E of SW Corner <u>BEAST 15R</u>	2" X 2" X 4' wood post
No. 4: Northwest Corner	WC 1,225' E of NW Corner <u>BEAST 15R</u>	2" X 2" X 4' wood post

As erected on the ground, each corner monument is marked as described above by a scribed metal tag. The work of location consisted of making a claim map as provided in N.R.S. 517.040 which map is recorded herewith.
