The claim is approximately 1500 feet long and 90 feet wide, such that 25 feet are claimed in a westerly direction and 1475 feet in a easterly direction from the point of discovery (monument of location), at which the Notice of Location was posted, together with 45 feet on each side of the monument of location and center line of the claim. The general course of the lode or vein is from the westerly to the easterly direction.
