TOGETHER WITH ALL AND SINGULAR, the tenements, hereditaments and appurtenances belonging thereto or in anyways appertaining thereto.

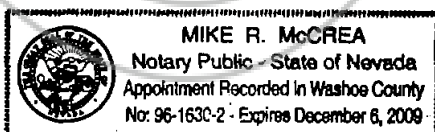

UTILITY EASEMENT RELINQUISHMENT

Relinquishment of an easement for utility purposes located in Section 36, Township 34 North, Range 51 East, M. D. B. & M., and Section 31, Township 34 North, Range 52 East, M. D. B. & M., Eureka County, Nevada, being a portion of that existing utility easement granted to Sierra Pacific Power Company recorded in the office of the Eureka County Recorder, Eureka, Nevada, in Book 180 at Page 486 of Eureka County Nevada Official Records. The portion of said existing utility easement being relinquished is 90.00 feet in width, lying 45.00 feet on each side of the following described centerline:

Commencing at the Northwest Corner of said Section 31, a point from which the Northeast Corner of said Section 31 bears N 89° 39' 03" E, 5337.16 feet, thence S 33° 58' 07" E, 2591.79 feet to Corner No. 1, a point being on the centerline of the said existing easement granted to Sierra Pacific Power Company, the True Point of Beginning;

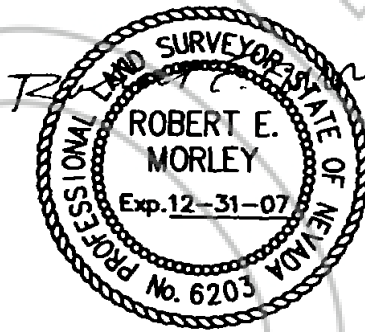

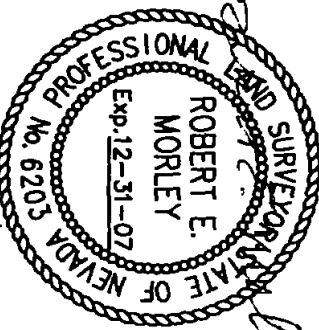
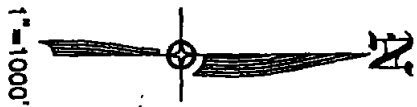
