**THIS DEED OF CORRECTION**, made this 19th day of October, 2006, by and between Newmont USA Limited, a Delaware corporation, d/b in Nevada as Newmont Mining Corporation, Grantor; and Newmont Nevada Energy Investment LLC, a Delaware limited liability company, Grantee;

**Whereas**, Grantor and Grantee made that certain Grant, Bargain and Sale Deed recorded as File Number 205728 Official Records, Eureka County, Nevada Recorder's Office; and,

**Whereas**, Grantee's name in said Grant, Bargain and Sale Deed is incompletely stated as "Newmont Nevada Energy Investment", and the parties desire hereby to state Grantee's name fully as "Newmont Nevada Energy Investment LLC"; NOW THEREFORE,

**IN WITNESS WHEREOF**, the said Grantor has caused this Deed to be executed as of the day and year first hereinabove written.

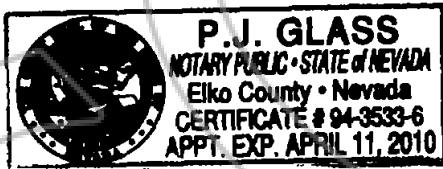
