ORDER APPROVING REPORT OF ADMINISTRATION, WAIVER OF
ACCOUNTING, PETITION FOR FINAL DISTRIBUTION, AND
FOR PAYMENT OF ATTORNEY'S FEES AND COSTS

15 Petitioner, John Robert Kenneson, Executor of the Estate of
16 August Pierresteguy, also known as Auguste Pierresteguy, having
17 rendered and filed his Report of Administration, Waiver of
18 Accounting, Petition for Final Distribution, and Application for
19 Order Authorizing Payment of Attorney's Fees and Costs, and that
20 said petition having come on regularly for hearing, this 1st day of
21 December, 2006, and proof having been made to the satisfaction of
22 the Court that Notice of said hearing on the Report of
23 Administration, Waiver of Accounting Petition for Final
24 Distribution, and Application for Order Authorizing Payment of
25 Attorney's Fees Costs, and was given in the manner and for the time
26 required by law, the Court finds:

1 1. That due and legal notice to the creditors of said Estate
2 has been given in the manner and for the time required by law.

3 2. That all of the known debts of the Estate have been paid.

4 3. That the whole of said Estate was the separate property
5 of the Decedent.

6 4. That the Petitioner is entitled to a fee for services
7 rendered on behalf of said Estate, however, he has agreed to waive
8 said fees.

9 5. That Anthony J. Montisano, Jr., Esq., attorney for the
10 Estate, is entitled to receive the sum of \$9,750.84, for ordinary
11 services performed in connection with said Estate. Said attorney
12 is also entitled to a fee for extraordinary services rendered on
13 behalf of the Estate in the amount of \$1,327.50, for obtaining an
14 ex parte order to open the safe deposit box at Bank of America, in
15 order to retrieve the original will. Further, Anthony J.
16 Montisano, Jr., has advanced the sum of \$403.50 for costs expended
17 during the course of the administration of the Estate. Said
18 attorney, however, has already received a retainer from Petitioner
19 in the amount of \$750.00.

20 6. That the Decedent executed his Last Will and Testament on
21 June 8, 1998, and the same has been lodged with the Court.

22 7. That under the provisions of the Decedent's Last Will and
23 Testament, he devised and bequeathed his property as follows:

24 "FOURTH: I give and bequeath all of my
25 property, both real and personal, of whatever
26 kind or description and wherever located to
 JOHN ROBERT KENNESON, with my love and deepest
 affection."

1 8. That the only beneficiary of the Estate, John Robert
2 Kenneson, has waived an accounting of the assets and liabilities of
3 said Estate, as well as notice of these proceedings.

5 costs, and any other costs incurred in the administration of the
6 Estate, that the Petitioner is to distribute all of the rest,
7 residue and remainder of said Estate to John Robert Kenneson, which
8 includes the following assets:

3 1. That the Report of Administration, Waiver of Accounting,
4 Petition for Distribution, and Application for Order Authorizing
5 Payment of Attorney's Fees and Costs, be, and the same is hereby
6 approved, allowed and settled, and that the facts, accounts and
7 matters alleged and reported therein are a true, complete and
