**CERTIFICATE OF LOCATION**

The name of the claim is the RX 1

This claim was located on 12/7/2006, by posting a Location Notice at the discovery monument.

The length of the claim is 100 feet in a North direction and 300 feet in the opposite direction from the  
monument where the Location Notice is posted, and the width is 100 feet on each side of the center of the vein  
or lode, comprising in all 400 feet in length and 200 feet in width, and generally following a north-south  
course.

The exterior boundaries are distinctly marked by four substantial monuments. Each corner monument
