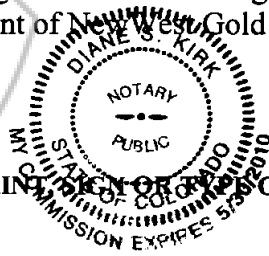

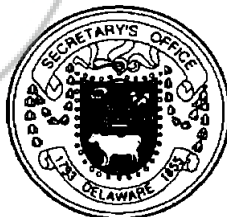

FOURTH: The merger is to become effective on October 2, 2006.


