

**SUBSTITUTION OF TRUSTEE AND DEED OF RECONVEYANCE**



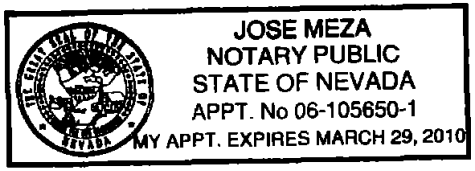
