NOTICE IS HEREBY GIVEN that, effective as of the 30" day of December, 2006 (the "Effective Date"), PAMELA S. SCUTT, RICHARD McKAY and NANCY MINOLETTI, whose addresses are c/o Richard McKay, 2749 MiraBella Circle, Morgan Hill, California 95037 (collectively, "Lessor"), and RMP RESOURCES CORP., a Nevada corporation whose address is Attn: Alan Branham, 2778 Spokane Creek Road, East Helena, Montana 59635 ("Lessee"), have entered into a Mineral Lease Agreement and Option to Purchase (the "Agreement") concerning the real property in Eureka County, Nevada described in Exhibit A attached hereto and incorporated herein, including any amendments or relocations thereof and all rights, improvements, privileges, hereditaments, and appurtenances, including all ores, minerals, waste dumps, tailings materials, water rights and mineral rights, belonging or in any way appertaining thereto, which property is referred to collectively in the Agreement and herein as the "Premises."
