CERTIFICATE OF LOCATION

Lode Mining Claim

NOTICE IS HEREBY GIVEN that **Barrick Gold U.S. Inc.**,
136 E. South Temple, Suite 1300, Salt Lake City, UT 84111, hereby claims
under and pursuant to the laws of the State of Nevada and of the laws of the
United States of America the following described **LODE MINING CLAIM**:

The name of the claim is the BCB 6.

This claim was located on January 14, 2007, by posting a Location Notice at the discovery monument.

The length of the claim is 750 feet in a NORTH direction and 750 feet in the opposite direction
from the monument where the Location Notice is posted, and the width is 300 feet on each side of the center of
the vein or lode, comprising in all 1500 feet in length and 600 feet in width, and generally following a
north-south course.

The exterior boundaries are distinctly marked by four substantial monuments. Each corner monument
consists of a 1-1/2" x 1-1/2" x 4 wooden post with aluminum tags attached, scribed with claim name and corner
description, set one foot in the ground. The boundaries can be readily traced by beginning at corner No. 1, the
NE corner:

thence	<u>1500</u>	feet	<u>south</u>	to the	<u>SE</u>	corner, corner No. 2,
thence	<u>600</u>	feet	<u>west</u>	to the	<u>SW</u>	corner, corner No. 3,
thence	<u>1500</u>	feet	<u>north</u>	to the	<u>NW</u>	corner, corner No. 4,
thence	<u>600</u>	feet	<u>east</u>	to the	<u>NE</u>	corner, corner No. 1, the point of beginning.


