- 2. OKIE W. GANNON, deceased, was the recipient of Medicaid benefits from May 1, 2002 through June 28, 2002, his date of death.
- 3. The State of Nevada Medicaid Program provided payment for medical services for the care of OKIE GANNON, in the amount of ELEVEN THOUSAND SIX HUNDRED TWENTY DOLLARS AND EIGHTY-SEVEN CENTS (\$11,620.87) through January 26, 2005.
- The undivided estate of OKIE W. GANNON included real property whose 4. common address is Vacant Land on 450 4th Street, Crescent Valley, Nevada 89821, and whose legal description is as follows:

All that certain real property situate in the County of Eureka. State of Nevada that is described as follows:

LOT 4. BLOCK 8. CRESCENT VALLEY RANCH & FARMS UNIT 4, as recorded

- 5. The estimated taxable value of the real property described above is SEVEN THOUSAND FOUR HUNDRED EIGHTY DOLLARS (\$7,480.00).
- At the time of OKIE W. GANNON's death, he owned the property with Hallie L. 6. Gannon and had a one-half (1/2) interest in the property. The Petitioner seeks to impose its lien only against the interest owned by OKIE W. GANNON at the time of his death. Pursuant to State and Federal law, the State may only recover on such a lien at a time when there is no surviving spouse, children under 21, or blind and/or disabled children of any age, if any. Additionally, the State must release its lien if the surviving spouse, child under 21, or disabled child, if any, seeks to engage in a bona fide sale or financial transaction involving the home.
- 7. The imposition of a lien upon the above-described real property of OKIE GANNON, a deceased Medicaid recipient, by the Nevada State Division of Health Care

Financing and Policy (Nevada Medicaid) is authorized and appropriate pursuant to Nevada Revised Statutes.

8. The imposition of a lien in the amount ELEVEN THOUSAND SIX HUNDRED TWENTY DOLLARS AND EIGHTY-SEVEN CENTS (\$11,620.87), which represents the amount of assistance paid on behalf of OKIE GANNON, a Medicaid recipient, by the Nevada State Division of Health Care Financing and Policy (Nevada Medicaid) is authorized and appropriate pursuant to Nevada Revised Statutes.

THEREFORE, based upon the foregoing, IT IS HEREBY ORDERED ADJUDGED AND DECREED AS FOLLOWS:

A lien, on behalf of the NEVADA STATE DIVISION OF HEALTH CARE FINANCING AND POLICY (Nevada Medicaid), in the amount of ELEVEN THOUSAND SIX HUNDRED TWENTY DOLLARS AND EIGHTY-SEVEN CENTS (\$11,620.87) is hereby imposed against the real property of the undivided estate of OKIE GANNON, whose Vacant Land on 450 4th Street, Crescent Valley, Nevada 89821, and whose legal description is as follows:
