It is the intention of the Company to maintain, develop and hold the Claims as is provided for by law.



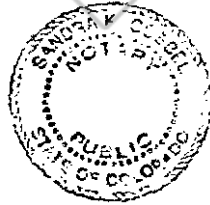
