18 Declaration of the Plaintiff for a Default Judgment, that the  
19 above-entitled Court has jurisdiction over the Plaintiff, **DESERT**  
20 **HEALTH CARE FACILITIES, INC. dba HIGHLAND MANOR OF ELKO**, and the  
21 Defendant, **JOANN FREE**, and in the subject matter contained in the  
22 Plaintiff's Complaint; that the Defendant, **JOANN FREE**, has been  
23 duly and personally served, through her legal representative,  
24 **VICKIE DRENNON**, with a copy of the Summons and Complaint in this  
25 action as required and directed by law more than twenty (20) days  
26 prior hereto; that the above-named Defendant has not appeared  
27 herein by answer, motion or other belief; and that the time to  
28 appear, answer, move or file any pleading has expired, AND GOOD  
CAUSE APPEARING THEREFOR,

1 IT IS HEREBY ORDERED that the Default of the Defendant,  
2 **JOANN FREE**, be and the same is hereby entered by the Court.

3 IT IS FURTHER APPEARING TO THE COURT:

4 1. That Plaintiff is entitled to Default Judgment  
5 against the Defendant, **JOANN FREE**, as the Defendant is indebted to  
6 the Plaintiff in the sum of \$18,164.75 for care received, for which  
7 the Defendant has failed and refused to pay.

8 2. That Plaintiff is entitled to a reasonable attorney  
9 fee in the sum of \$2,500.00, together with court costs incurred to  
10 date of \$194.00 and court costs to be incurred by Plaintiff in  
11 connection herewith.

12 3. That Plaintiff is entitled to interest on the sum of  
13 \$18,164.75 at the rate of one and one-half percent (1.5%) per month  
14 from April 30, 2007, until paid.

15 NOW, THEREFORE, IT IS HEREBY ORDERED, ADJUDGED AND  
16 DECREED that the Plaintiff have judgment against the Defendant,  
17 **JOANN FREE**, as follows:

18 1. Principal sum of \$18,164.75.

19 2. For interest on the principal sum of \$18,164.75 at  
20 the rate of one and one-half percent (1.5%) per month from the date  
21 of April 30, 2007, until paid.

22 3. The sum of \$2,500.00 as and for reasonable attorney  
23 fees.

24 4. Court costs incurred to date of \$194.00 and court  
25 costs to be incurred by Plaintiff in connection herewith.
