Persons or corporations dealing with the Trustees are expressly exonerated from any duty to inquire into the authority or power of the Trustees or to see to the application of money or property delivered to the Trustees. The Trustees are not authorized to furnish copies of the Trust to any persons except as may be required by order of a court

having jurisdiction of the Trust or Trustees, or if required under any law or regulation having the effect of law, or upon our express written permission.
