4. KM will not be responsible for the construction, alteration or repair, or the intended construction, alteration or repair, of any improvements on the Claims.

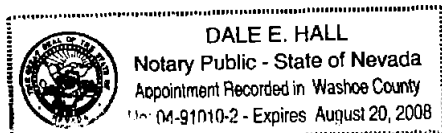

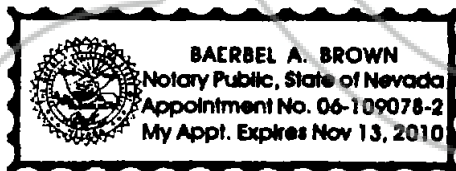
