
**NOTICE OF INTENT TO HOLD UNPATENTED MINING CLAIMS

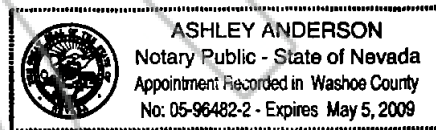
