**CERTIFIED EXTRACT AND CERTIFICATION
FOR GERALDINE E. THOMAS 1990 TRUST
under declaration of trust 11/21/1990**

THE UNDERSIGNED, being duly sworn, depose and certify:

1. This certification of trust is made and executed pursuant to Nevada Revised Statutes section 164.400 to section 164.440, for the purpose of establishing the existence and terms of the trust.

2. The undersigned, LEE WARD THOMAS and NEIL HAINES THOMAS are the successor Trustees, pursuant to Article 5.2 of the GERALDINE E. THOMAS 1990 TRUST; said Trust is dated November 21, 1990. In the event of incapacity or death of either LEE WARD THOMAS and NEIL HAINES THOMAS, the successor is nominated to serve as sole Trustee.

3. That GERALDINE E. THOMAS executed the herein described Declaration of Trust in her capacity as both Settlor and Trustee; said Declaration of Trust is not of record in any Court. At the time of execution of the trust, GERALDINE E. THOMAS was a resident of Clark County, Nevada.

4. That the present beneficiaries under the terms of said Declaration of Trust are the Trustor's surviving children, LEE WARD THOMAS and NEIL HAINES THOMAS, by right of representation. The named children are the beneficiaries as designated in the Declaration of Trust. There are no predeceased children.

5. During the Trustor's lifetime, the Trustor, GERALDINE E. THOMAS was the Trustee of this trust; following Trustor's death or incapacity, LEE WARD THOMAS and NEIL HAINES THOMAS were nominated to serve as successor co-trustees.

6. That the powers and authority of the original Trustee as well as all successor Trustees, with respect to the trust property include, by way of illustration, the following:

- A. To sell, conveyance and exchange;
- B. To rent or lease property, including oil, gas and minerals;

- C. To hypothecate, pledge or encumber property;
- D. To purchase and maintain insurance;
- E. To commence and defend litigation;
- F. To invest trust funds as the Trustee shall deem advisable;
- G. To exercise subscriptions or options;
- H. To enforce any mortgaged, deed of trust or pledge;
- I. To compromise, arbitrate and adjust claims;
- J. To borrow money;
- K. To hold securities in Trustee's name, and to transfer title to securities;
- L. To vote all securities;
- M. To determine principal and income;
- N. To pay property taxes, assessments, fees and charges;
- O. To pay income and estate taxes; and
- P. To distribute trust property.

7. This trust could be terminated by Settlor, GERALDINE E. THOMAS, during her lifetime.


8. Both Co-Trustees must act to exercise identified powers, unless only one of them has qualified as successor trustee.
