It is the intention of the COMPANY to maintain, develop and hold each Claim since its date of location as is provided for by law.



the amount of one hundred and twenty-five dollars (\$125.00) for each of the Claim(s).

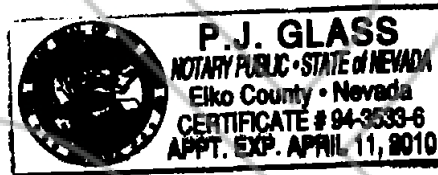
