
Being duly authorized, I make this affidavit on behalf of Metalwind Ltd., 2017 E. 3/4 Rd., Grand Junction, CO 81503.

1. 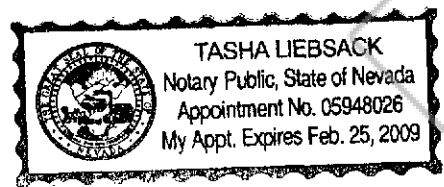
Sites. It is the owner's intention to hold each of the Claims and Mill Sites through the assessment year ending September 1, 2008.
