
**AFFIDAVIT OF NOTICE OF INTENT TO HOLD UNPATENTED MINING CLAIMS

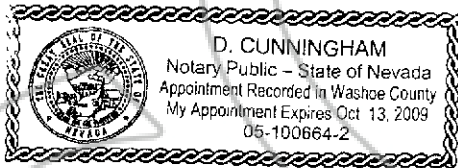
