

CERTIFICATE OF LOCATION
LODE MINING CLAIM

NOTICE IS HEREBY GIVEN that WFW RESOURCES, LLC, a Nevada limited liability company, whose mailing address is 441 Fir Street, Elko, Nevada 89801, has located the WFWKV 56 lode mining claim, more particularly described below, on the 12th day of November, 2007.

The claim is approximately 1,500 feet long and 600 feet wide, such that 1490 feet are claimed in a Northerly direction and 10 feet in a Southerly direction from the point of discovery (monument of location), at which a Notice of Location was duly posted, together with 300 feet on each side of the monument of location and center line of the claim. The monument of location upon which the Notice of Location was posted is a wood post measuring at least 1½" x 1½" x 4", set one foot in the ground. The general course of the lode or vein is from the Northerly to the Southerly direction.

The exterior boundaries of the claim are distinctly marked by four wooden posts measuring at least 1½" x 1½" x 4", set one foot in the ground, one at each corner. The boundaries of the claim are described as follows: Beginning at the NE corner of the claim, which is corner No. 1 (marked NE Corner WFWKV 56), from which the SW corner of Section 20, Township 22 North, Range 51 East, MDM lies approximately 9128 feet South and 1 foot West:

thence 1500 feet South to the SE Corner, which is corner No. 2, marked SE Corner WFWKV 56,
thence 600 feet West to the SW Corner, which is corner No. 3, marked SW Corner WFWKV 56,
thence 1500 feet North to the NW Corner, which is corner No. 4, marked NW Corner WFWKV 56,
thence 600 feet East to said corner No. 1, the point of beginning.

The corners were so marked on the posts with black ink, or were marked on a scribed aluminum tag attached to the post.


The claim is located within the:

NE¼ of Section 18, Township 22 North, Range 51 East,
SE¼ of Section 18, Township 22 North, Range 51 East,
NW¼ of Section 17, Township 22 North, Range 51 East,
SW¼ of Section 17, Township 22 North, Range 51 East, MDM, Eureka County, Nevada.

The boundaries of the claim were defined as required by law within 60 days from the date of posting of the Notice of Location. The work of location consisted of making the claim map as provided in N.R.S. § 517.040.
