AMENDED CERTIFICATE OF LOCATION

LODE MINING CLAIM

This document amends the original certificate of location, as filed in Eureka County on June 8, 2007 (instrument number 209930, book 458, page 398), which failed to identify the section, township, and range of subject claim.

NOTICE IS HEREBY GIVEN that RMP RESOURCES CORP., a Nevada corporation and citizen of the United States whose mailing address is 2778 Spokane Creek Road, East Helena, Montana 59635, has located the BUFF 48 lode mining claim, more particularly described below, on the 5th day of May, 2007.
