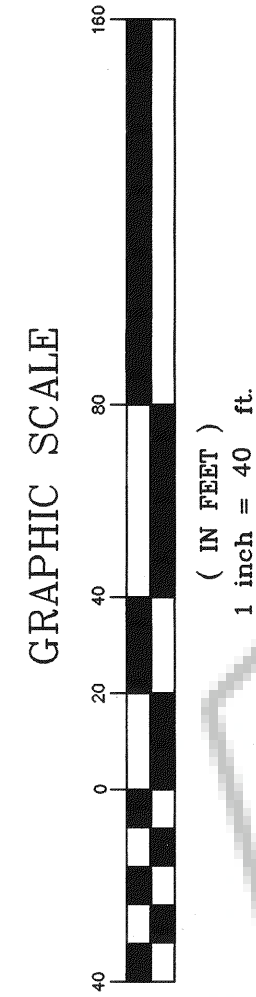
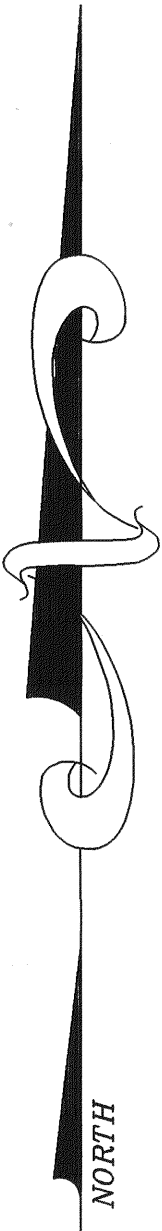


BASIS OF BEARING: GPS OCCUPATION OF FOUND MONUMENTS EAST LINE BLOCK 20

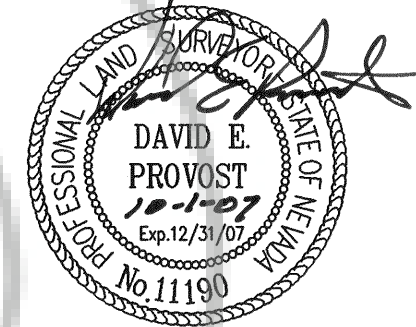

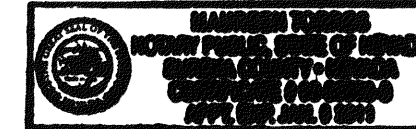

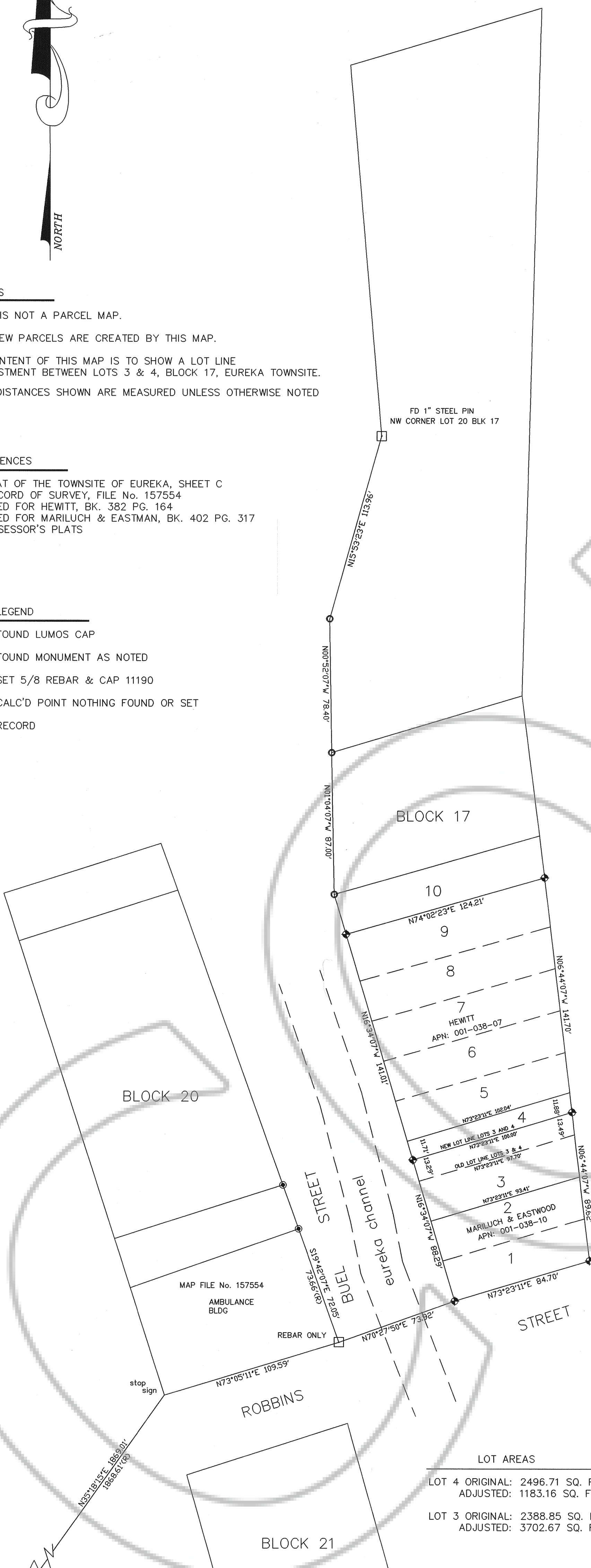
