1 This action came on for trial before the Court and a jury on Tuesday, September 26, 2006,
2
3 at 1:30 p.m. through Tuesday, October 3, 2006, the Honorable Michelle Leavitt,
4 presiding. The jury rendered a verdict in favor of the plaintiff, JOHN KEMPTHORNE, and against
5 the Defendants, ROBERT T. KNOTT, JR. and ROBERT E. GLENNEN III, in the amount of
6 \$500,000.00 in past general damages. The jury found for the Plaintiff, JOHN KEMPTHORNE, and
7 against the Defendant, ROBERT T. KNOTT, JR., in the amount of \$5,000,000, in punitive damages.
8
9 The jury found for the Plaintiff, JOHN KEMPTHORNE, and against the Defendant, ROBERT E.
10 GLENNEN III, in the amount of \$3,000,000, in punitive damages.

11 THEREFORE, IT IS ORDERED, ADJUDGED AND DECREED that, Plaintiff, JOHN
12 KEMPTHORNE, recover from the Defendant, ROBERT T. KNOTT, JR., the sum of \$500,000
13 as past damages, with prejudgment interest thereon at the rate provided by law of 10.25% from
14 February 4, 2005 (date of answer for Defendant Knott), until January 11, 2007, in the sum of
15 \$99,270.55, and post judgment interest on the sum of \$599,270.55, at the rate provided by law from
16 the date of entry of this Judgment;
17

18 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that, Plaintiff, JOHN
19 KEMPTHORNE, recover from the Defendant, ROBERT E. GLENNEN III, the sum of \$500,000
20 as past damages, with prejudgment interest thereon at the rate provided by law of 10.25% from
21 October 12, 2004 (date of service on Defendant Glennen), until January 11, 2007, in the sum of
22 \$115,417.81, and post judgment interest on the sum of \$615,417.81, at the rate provided by law
23 from the date of entry of this Judgment.


