CERTIFICATE OF LOCATION

NOTICE IS HEREBY GIVEN that RMP RESOURCES CORP., a Nevada corporation and citizen of the United States whose mailing address is 2778 Spokane Creek Road, East Helena, Montana 59635, has located the BUFF 55 lode mining claim, more particularly described below, on the 16 day of October, 2007.
