CERTIFICATE OF LOCATION

LODE MINING CLAIM

NOTICE IS HEREBY GIVEN that **RMP RESOURCES CORP.**, a Nevada corporation and citizen of the United States whose mailing address is 2778 Spokane Creek Road, East Helena, Montana 59635, has located the BUFF 60 lode mining claim, more particularly described below, on the 10 day of December, 2007.
