ASSIGNMENT OF AMENDED WATER SUPPLY AGREEMENT

This Assignment of Amended Water Supply Agreement, made this 3rd day of March, 2008, by and between **RUBY HILL RANCH, LLC**, a Nevada limited liability company, hereinafter referred to as Ruby Hill, Assignor and **DUGAN ENTERPRISES, LLC**, a Nevada limited liability company, hereinafter referred to as Dugan, Assignee.

RECITALS

WHEREAS, Ruby Hill entered into an Amended Water Supply Agreement dated July 20, 2006, hereinafter referred to as the Agreement, with Devil's Gate General Improvement District, a political subdivision of the State of Nevada, hereinafter referred to as Devil's Gate, which Agreement was recorded in the office of the County Recorder of Eureka County, Nevada, on July 31, 2007, in Book 439 of Official Records at page 339, and

WHEREAS, said Agreement provides that Devil's Gate shall provide domestic water to lands owned by Ruby Hill in Section 21, Township 20 North, Range 53 East, M.D.B.&M. and other lands owned by Ruby Hill, subject to the terms and conditions set forth in said Agreement, and

WHEREAS, said Agreement provides that the rights set forth therein shall inure to the benefit of the successor developer of Ruby Hill, the terms of the Agreement shall run with the land described and may be assigned or transferred to successor developer, and

WHEREAS, said Agreement states it may only be applied for domestic use to forty-one (41) lots developed or to be developed, and

WHEREAS, Ruby Hill conveyed one (1) lot which is the subject of the Agreement, leaving a remainder of forty (40) lots subject thereto.

NOW, THEREFORE, Ruby Hill assigns, conveys and assigns to Dugan all of its right, title and interest under said Agreement,



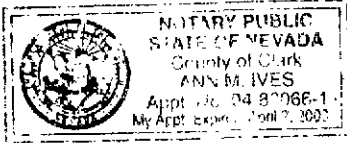
