INTERLOCAL CONTRACT BETWEEN THE EUREKA COUNTY TELEVISION DISTRICT AND EUREKA COUNTY

- 100. The parties to this interlocal contract understand and agree that:
 - A. N.R.S. 277.180 governs interlocal contracts between public agencies to perform any governmental service, activity or undertaking which any of the public agencies entering into the contract is authorized by law to perform; and
 - B. The EUREKA COUNTY TELEVISION DISTRICT is a nonprofit television district serving all of EUREKA COUNTY, and is a public agency pursuant to N.R.S. 277.100; and
 - C. EUREKA COUNTY is a political subdivision of the State of Nevada and as such is a public agency pursuant to N.R.S. 277.100; and
 - D. The EUREKA COUNTY TELEVISION DISTRICT and EUREKA COUNTY have traditionally worked together to accomplish the tasks necessary to ensure services are provided to the citizens of EUREKA COUNTY; and
 - E. The EUREKA COUNTY TELEVISION DISTRICT is in the process of updating and improving the tower and shelter structures under its jurisdiction; and
 - F. EUREKA COUNTY is in the process of updating and improving its radio and communications equipment; and

- G. The parties wish to memorialize their understanding of their working relationship by this contract.
- 200. EUREKA COUNTY agrees to provide to the EUREKA COUNTY TELEVISION DISTRICT the following:
 - A. EUREKA COUNTY will provide road maintenance to gain access (weather permitting) to the tower and shelter sites known as Prospect and TV Mountain.
 - B. EUREKA COUNTY will store, operate, and maintain one (1) Snow Cat in southern EUREKA COUNTY. Requests for operation of the Snow Cat must be made at least two (2) working days in advance to the EUREKA COUNTY Department of Public Works unless an emergency arises.
 - C. EUREKA COUNTY will pay to the EUREKA COUNTY TELEVISION BOARD during the 2007-2008 fiscal year the sum of Two Hundred Thirty Thousand Dollars (\$230,000.00) to be used exclusively for equipment upgrades. This payment shall be in lieu of rent during the term of this contract.
- 300. EUREKA COUNTY TELEVISION DISTRICT agrees to provide to EUREKA COUNTY the following:
 - A. EUREKA COUNTY TELEVISION DISTRICT will operate and maintain the towers and shelters and be responsible for the power, heating, and any other utility bills.
 - B. EUREKA COUNTY TELEVISION DISTRICT will allow EUREKA COUNTY to utilize the District's towers and shelters to install radio and communications equipment for fire and public safety purposes.
 - C. EUREKA COUNTY TELEVISION DISTRICT will not charge EUREKA COUNTY rent for the tower and shelter space utilized by EUREKA COUNTY for fire and public safety radio and communications equipment.
- 400. The term of this contract is for twenty (20) years, and shall be extended for one (1) additional twenty (20) year term if no action is taken by either party to revoke, amend, or rescind this interlocal contract.
- 500. According to N.R.S. 244.320, this contract, which extends beyond the term of the sitting Board of County Commissioners for EUREKA COUNTY, is binding only to

the extent money is appropriated for the contract. Each party to this contract pursuant to N.R.S. 277.180(4) shall annually, at the time of preparing its budget, include an estimate of the expenses necessary to carry out this agreement.

- 600. This contract may only be revoked, amended, or rescinded prior to its expiration by mutual agreement of the parties, but in no event may be terminated sooner than the end of March, 2028.
- 700. By signing below, the parties agree to the terms of this contract, and represent that their respective Boards, during an open meeting, have approved of this contract as written:
