LAM 1 through LAM 28, inclusive

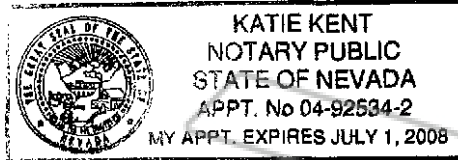

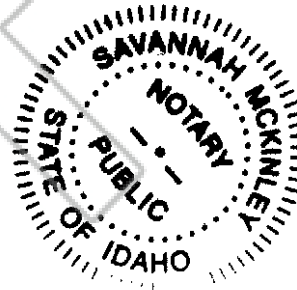
