ORDER HOLDING DEFENDANT MR. MCMASTER IN CONTEMPT OF COURT & ORDER REDUCING ATTORNEY'S FEES AND COSTS TO JUDGMENT

This matter came before the Court pursuant to Plaintiff Joanne McMaster's ("Ms. McMaster) Motion for Order to Show Cause Why Defendant Should Not Be Held In Contempt, filed September 25, 2006. Plaintiff properly served the motion on Defendant by mail service. Defendant Larry McMaster ("Mr. McMaster") never filed a response to Ms. McMaster's contempt motion. Ms. McMaster submitted her contempt motion on October 30,

2006. On December 21, 2006, the Court entered an Order to Show Cause, directing the parties to appear before the Court on March 7, 2007, at 1:30 p.m., to determine if Mr. McMaster should be held in contempt for failing to pay any of the attorney's fees and costs awarded to Ms. McMaster pursuant to the Court's June 9, 2006, Order Granting Attorney's Fees and Costs. On March 7, 2007, Mr. McMaster, in pro per, appeared before the Court telephonically and Mr. John F. Keuscher, Esq., appeared on behalf of Ms. McMaster. The Court heard the arguments of counsel and Mr. McMaster, and took testimony of Mr. McMaster under oath.

After reviewing the papers and pleadings filed by the parties herein, and after hearing and considering the arguments and testimony presented before the Court at the hearing, the Court hereby enters the following findings of fact:

FINDINGS OF FACT

- 1. The Court finds that Mr. McMaster has not paid any of the \$5,765.25 in attorney's fees and costs ordered to be paid by the Court's Order Granting Attorney's Fees and Costs, entered June 9, 2006.
- 2. The Court further finds that Mr. McMaster has provided no evidence justifying his nonpayment of the attorney's fees and costs.

<u>ORDER</u>

Therefore, based on the foregoing, and good cause appearing, the Court finds Mr. McMaster in contempt of court for failing to pay the \$5,765.25 as ordered by the Court's Order Granting Attorney's Fees and Costs, entered June 9, 2006.

The Court reduces the amount of \$5,765.25 to judgment and enters judgment against Mr. McMaster in the total sum of \$5,765.25 with interest thereon at the legal rate retroactive from the date of judgment.
