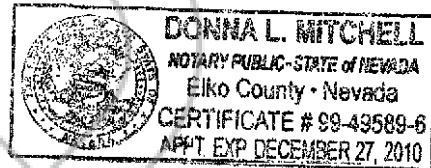

SCHEDULE A

LOOKOUT PROPERTY
MINING LEASE AND AGREEMENT

THIS MINING LEASE AND AGREEMENT (the Agreement), made this 22nd day of August, 2003, by and between Rocky Canyon Mining Company, a Colorado corporation (hereinafter called "Owner"), and Century Gold, LLC, a Nevada Limited Liability company (hereinafter called Century Gold).

WITNESSETH:

1. Owner represents that it owns an interest in the mineral rights described on Exhibit A attached hereto and incorporated herein (hereinafter referred to as the Property), located in Eureka County, Nevada; that to the best of the Owner's knowledge, the Property is free and clear of all liens, clouds, encumbrances and other adverse claims of third parties; that Owner has good and valid right and authority to make and deliver this Agreement; and that the Property is not burdened with any royalties, overriding royalties, net profits interests or payments on production other than the royalty and payments payable to Owner hereunder, and a royalty identified as the Bisoni Royalty. Owner further represents that to the best of its knowledge the Property is not adversely affected by rulings or decisions of federal, state or local agencies, it being understood by the parties that the surface thereof is owned and administered by the United States of America.

2. Owner hereby grants, lets and leases exclusively to Century Gold, all of its right, title and interest in and to the Property and the lands described in Exhibit A, for the term hereof, together with all ores and minerals of every kind, as granted by unpatented mining claims, except oil and gas, in, on or under the Property, with all of Owner's rights to prospect and



explore for, mine by any method now known or hereafter discovered (including, but not limited to, underground, open pit, in situ and solution methods), process by any method now known or hereafter discovered, mill, prepare for market, store, sell and dispose of the same; and together with all such rights-of-way, easements, water and water rights, geothermal water and geothermal resources, of every kind and nature, through, over, on or appertaining to the Property, if any; and together with all of Owner's rights to erect, maintain and operate thereon and therein, such buildings, structures, machinery and equipment, and the right to use, occupy and disturb so much of the surface of the Property as Century Gold may determine to be useful, desirable or convenient for the exercise by Century Gold of any and all of its rights hereunder. In the event Owner acquires any additional rights, title or interests in the Property after the execution of this Agreement, all such additional rights, title and interests shall be subject to this Agreement.

3. If Owner's title is less than 100% ownership, all payments including Advance and Production Royalty payments, without limitation, to be made to Owner hereunder shall be reduced to the same proportion as the undivided interest actually owned by Owner bears to 100% ownership of the Property.

Century Gold shall have sole discretion to determine the extent of its work, if any, on the Property and the time or times for beginning, continuing or resuming such work thereon. Century Gold shall at all times and at its own expense comply in all aspects with all county, state and federal laws, statutes, ordinances, rules and regulations relating to its activities under this Agreement or on the Property, including any requirement to pay fees or post a bond.

Century Gold shall indemnify and hold harmless Owner from all liability, including attorneys fees and costs, arising out of Century Gold's exploration and other activities



hereunder, including but not limited to environmental and reclamation liabilities under existing and future laws and regulations. The indemnity set forth herein shall survive termination or expiration of this Agreement.

Owner shall indemnify and hold harmless, Century Gold's officers, directors, shareholders, employees and affiliates from any and all claims, demands and liabilities whatsoever arising from or in connection with other operations or activities upon the Property whether or not prior to the date of this Agreement, including without limitation, surface and underground disturbances (including, but not limited to gravel operations, underground workings, waste dumps, tailings, roads, drill holes and drill pads) and reclamation obligations. The indemnity set forth herein shall survive termination or expiration of this Agreement.

4. The term of this Agreement shall begin with the date hereof and shall continue to and until the 20th anniversary of such date, and so long thereafter as minerals are mined, produced or sold from the Property, but subject to earlier termination as provided in this Agreement. After termination of this Agreement, Century Gold shall have the right of ingress and egress from the Property and the right to complete such reclamation or restoration of the Property and to make such inspections as may be required by law, for so long after termination of this Agreement as is necessary to complete all such reclamation, restoration and inspections.

5. Unless and until this Agreement is sooner terminated, Century Gold shall pay Owner Advance Royalty payments in accordance with the following schedule:

<u>Advance Royalty Payment</u>	<u>Payable on or before</u>
(a) \$1,000.00 per month	On execution, and monthly thereafter until the conditions of paragraph (b) below are met.

| (c) | \$3,000.00 per month | On March 1, 2005, and each and every month thereafter for the duration of this agreement. |

All Advance Royalty payments payable to Owner pursuant to this paragraph shall be credited to and recoverable from Production Royalty payments payable by Century Gold to Owner. Said right of recovery shall apply to the first such Production Royalty payments accruing and shall continue thereafter until Century Gold has recovered the full amount of previously paid Advance Royalty payments.

After September 1, 2004, pursuant to paragraph 11 below, Century Gold shall have the right to release portions of the Property from the provisions of this Agreement, and to reconvey to Owner all rights granted to Century Gold in such portions of the Property. However, there shall be no reduction in Advance Royalty payments or the Production Royalty payments thereafter accruing.

Century Gold shall pay to Owner a Production Royalty of three and one-half percent (3½ %) of net smelter returns. Net smelter returns shall be calculated for each calendar quarter in which net smelter returns are realized, and such royalty payments as are due Owner hereunder shall be made within thirty (30) days following the end of the calendar quarter in which the net smelter returns were realized. Such payments shall be accompanied by a statement summarizing the computation of net smelter returns.

Quarterly royalty payments will be provisional and subject to adjustment at the end of Century Gold's accounting year, i.e., December 31.

The term "net smelter returns" (NSR) as used herein shall mean the net proceeds received by Century Gold from the sale of minerals from the Property after deductions for all of the following:

- (i) Custom smelting costs, treatment charges and penalties including, but without being limited to, metal losses, penalties for impurities and charges or deductions for refining, selling, and transportation from smelter to refinery and from refinery to market; provided, however, in the case of leaching operations, all processing and recovery costs incurred by Century Gold beyond the point at which the metal being treated is in solution shall be considered as treatment charges (it being agreed and understood, however, that such processing and recovery costs shall not include the cost of mining, crushing, dump preparation, distribution of leach solutions or other mining and preparation costs up to the point at which the metal goes into solution);
- (ii) Cost of transporting mineral product from the concentrator to a smelter or other place of treatment; and
- (iii) Production taxes, severance taxes and sales, privilege and other taxes measured by production or the value of production.

All royalties payable hereunder may be made by Century Gold's check, and delivery thereof shall be deemed completed on the mailing thereof to Owner.

6. For a period of five (5) years from the date hereof with no provision for force majeure, Century Gold shall have the sole and exclusive option to purchase a 2½% NSR (leaving Owner a 1% NSR) from Owner for a price of ONE MILLION FIVE HUNDRED THOUSAND DOLLARS (\$1,500,000). Notice of exercise of the Option must be served pursuant to Section 16 below.

Closing date shall be within thirty days after written notice of exercise is served on Owner. Upon closing date Owner shall execute and deliver a good and sufficient Assignment of Royalty conveying the royalty interest to Century Gold in exchange for payment for royalty.



7. Without limiting the generality of the rights granted in Section 2, Century Gold is hereby granted the right to mine or remove from the Property any ores, waste, water or other materials existing therein or thereon, through or by means of shafts or openings which may be sunk or made upon adjoining or nearby property controlled by Century Gold, and may stockpile any ores, waste or other materials and/or concentrated products of ores or materials from the Property upon stockpile grounds situated upon any such adjoining or nearby property; and to the extent the Owner has the right, title and authority to grant such surface rights, Century Gold may use the Property and any part thereof and any shafts, openings, and stockpile grounds, sunk or made thereon for the mining, removal and/or stockpiling of any ores, waste, water and other materials and/or concentrated products of ores or materials from any such adjoining or nearby property.

Century Gold may commingle ore from the Property with ore from other properties, either before or after concentration or beneficiation, so long as the data to determine the weight and assay, both of the ore removed from the Property and of other ores to be commingled, are obtained by Century Gold in an industry accepted manner. Century Gold shall use that weight and assay data exclusively to allocate the royalties from the commingled ore between the Property and other properties from which the other commingled ore was removed. All such weight, assay and allocation calculations by Century Gold shall be done in a manner recognized by the mining industry as practical and sufficient.

8. Century Gold's records of all mining operations on the Property pertinent to computation of royalties shall be available for Owner's inspection, upon reasonable advance notice and during normal business hours, but no more than once each quarter, and Owner may

enter the mine workings and structures on the Property at all reasonable times upon reasonable advance notice for inspection thereof, but Owner shall so enter at its own risk and shall indemnify and hold Century Gold harmless against and from any damage, loss or liability by reason of injury to Owner or its agents or representatives, or damage to or destruction of any property of Owner or said agents or representatives while on the Property or on or in said mine workings and structures.

9. Century Gold shall pay all taxes assessed against any personal property which it may place on the Property and shall pay any taxes or increase in taxes assessed against the Property due to its operations and activities thereon. Owner shall provide promptly to Century Gold copies of all documents relating to such taxes or increases in taxes. Century Gold may take such action at its expense, as it deems proper to obtain a reduction or refund of taxes paid or payable by it, and Owner shall cooperate in such action.

10. Century Gold shall keep the Property free of all liens for labor or materials furnished to it in its operations hereunder and will indemnify and save harmless Owner against and from any damage, loss or liability by reason of injury to person or damage to property as the result of its operations hereunder, except as provided in Section 8 above. Century Gold may contest the validity of any lien of the Property at its expense, and Owner shall cooperate in such contest, including but not limited to allowing such contest to be taken and prosecuted in Owner's name, and any such lien shall not be deemed a default unless finally adjudicated to be valid and not discharged by Century Gold.

Owner will not cause or allow any liens, encumbrances or adverse claims to accrue against the Property, except such as may have been expressly subordinated to this Agreement; and in the event any lien or encumbrance shall hereafter accrue against the Property



by act or neglect of Owner, then Century Gold may, at Century Gold's option, pay and discharge the same, and if Century Gold elects so to do, Century Gold may deduct the amount so paid from any Production Royalties or other payments hereunder, together with interest thereon from the date of payment of said sums at the weighted average of prime rates throughout the year (as established by the Bank of America).

11. Century Gold is obligated to pay the 2003/2004 and 2004/2005 BLM Claim Maintenance and Eureka County Claim Filing Fees for all 373 Claims in this lease. After payment of the 2003-2004 and 2004-2005 BLM maintenance fees and county filings, Century Gold may terminate this Agreement at any time as to any or all claims by written notice to Owner to that effect. Century Gold shall pay the next annual BLM maintenance and county claim filing fees, if termination occurs after June 1st, in 2005 or subsequent years.

Annually, and upon termination of this Agreement, Century Gold shall furnish Owner with a complete summary of the factual information obtained as a result of work done by Century Gold on the Property including, but not limited to, logs of all holes drilled thereon, ore values encountered, if any, assay analysis thereof and pertinent factual maps and surveys prepared by Century Gold in the course of such work.

12. If Century Gold defaults in any of its obligations hereunder, Owner may give Century Gold written notice thereof and specify the default or defaults relied on. If Century Gold has not cured such default within a reasonable time after receipt of such notice (which shall be 30 days for payment defaults), Owner may terminate this Agreement by written notice to Century Gold; provided that if Century Gold shall dispute that any default has occurred, the matter shall be determined by litigation in a court of competent jurisdiction, and if Century Gold is found to be in default hereunder, Century Gold shall have a reasonable time (which in any case

shall not be less than 60 days from receipt by Century Gold of notice of entry of final judgment adverse to Century Gold) to cure such default, and if so cured, Owner shall have no right to terminate this Agreement by reason of such default.

13. The term of this Agreement may be extended in the case of an event of force majeure in accordance with the following:

a.) The term of this Agreement shall be extended by any event of force majeure, and the obligations of Century Gold under this Agreement, other than the payment of money, shall be suspended, and Century Gold shall not be deemed in default or liable for damages or other remedies while Century Gold is prevented from complying therewith by force majeure. For purposes of this Agreement, force majeure shall include, but not be limited to: acts of God; the elements; acts of War, insurrection, riots or terrorism; strikes, lockouts and other labor disputes; inability to obtain necessary material, damage to, destruction or unavoidable shutdown of necessary facilities or equipment; acts or failures to act on the part of local, state, or federal governmental agencies or courts; or any other matters (whether or not similar to those mentioned above, and whether foreseeable or unforeseeable) beyond Century Gold's reasonable control; provided, however, that settlement of strikes, lockouts and other labor disputes shall be entirely within the discretion of Century Gold; and provided further that Century Gold shall promptly notify other parties to this Agreement and shall exercise diligence in an effort to remove or overcome the cause of such inability to comply.

b.) In entering into this Agreement, the parties assume that Century Gold's access to the Property is and will continue to be unrestricted. Century Gold's reasonable belief that the actions or inactions of any local, state or federal governmental agency or court, or of any officer or official acting under color of governmental authority, might prevent or impede access



to the Property, or otherwise limit Century Gold's ability to operate thereon, shall be considered an event of force majeure for purposes of this Agreement, and shall be referred to as an "access force majeure." If an access force majeure occurs, subsection (a) of this section shall not apply, and Century Gold shall instead have the right to suspend this Agreement and extend its term for a period not to exceed two years, without payment or penalty, while the access force majeure is in effect, provided, however, that Century Gold shall resume operations on the Property within a reasonable time after access to the Property is no longer restricted. In determining "reasonableness," Century Gold shall be under no duty to contest said action or inaction by protest, petition, appeal or any other means.

14. In case of termination of this Agreement under the terms hereof or for any cause, Century Gold shall have no liability or obligation hereunder except for those already accrued at such date of termination. Upon such termination, Century Gold shall surrender the Property to Owner, subject to Century Gold's post-termination rights described in Section 4, and within 60 days of termination shall record a written instrument in further evidence of such termination, and deliver a copy to Owner. In addition to its post-termination rights described in Section 4, for the longer of three months or the post-termination period provided in said Section, Century Gold shall have the right, but not the obligation, to remove from the Property all property belonging to or installed by it, including but not limited to machinery, equipment, buildings, structures, fixtures, ores, waste, mined ores and other materials, and concentrated products of ores or other materials.

15. Changes in the ownership of the Property or the rights to receive royalties hereunder occurring after delivery of this Agreement shall not be binding upon Century Gold until it shall receive written notice of such change, signed by Owner, together with a certified

copy or photographic copy of the recorded documents reflecting such change. No change or division in the ownership of the Property, or the rights of Owner under this Agreement hereafter accomplished shall operate to enlarge the obligations or diminish the rights of Century Gold hereunder.

16. All notices hereunder shall be in writing and may be delivered by certified mail, and such mailing thereof shall be deemed the act of giving of notice. Such mailed notices shall be addressed to Owner in duplicate, as follows:

17. The parties will execute a short form of Agreement covering the Property for purposes of recording, which shall include a notice of non-responsibility.

18. Upon request, Owner will make available such abstracts of title and other title records pertaining to the Property which it may have to aid Century Gold in any title searching it may wish to undertake. Century Gold may investigate and cure as it sees fit any defects in title to the Property which Owner fails to remedy after notice by Century Gold. Owner agrees to cooperate fully with Century Gold in the curing of any such title defect, and Century Gold will reimburse Owner for Owner's actual expenses resulting from its cooperation in this effort. All expenses incurred by Century Gold in this effort or incurred by Owner and reimbursed by Century Gold shall be taken as a credit by Century Gold against any Production Royalties payable hereunder to Owner.



19. The rights and obligations of Century Gold may be assigned in whole or in part, with prior written consent of Owner, which consent shall not be unreasonably withheld.
