It is the intention of the COMPANY to maintain, develop and hold each Claim since its date of location as is provided for by law.

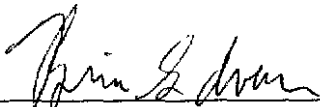

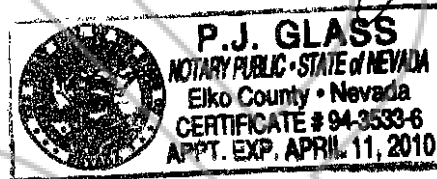
