
Being duly authorized, I make this affidavit on behalf of Nevada North Resources (USA) Inc., 501 South 1st Avenue, Suite N, Arcadia, CA 91006-3888.

1. 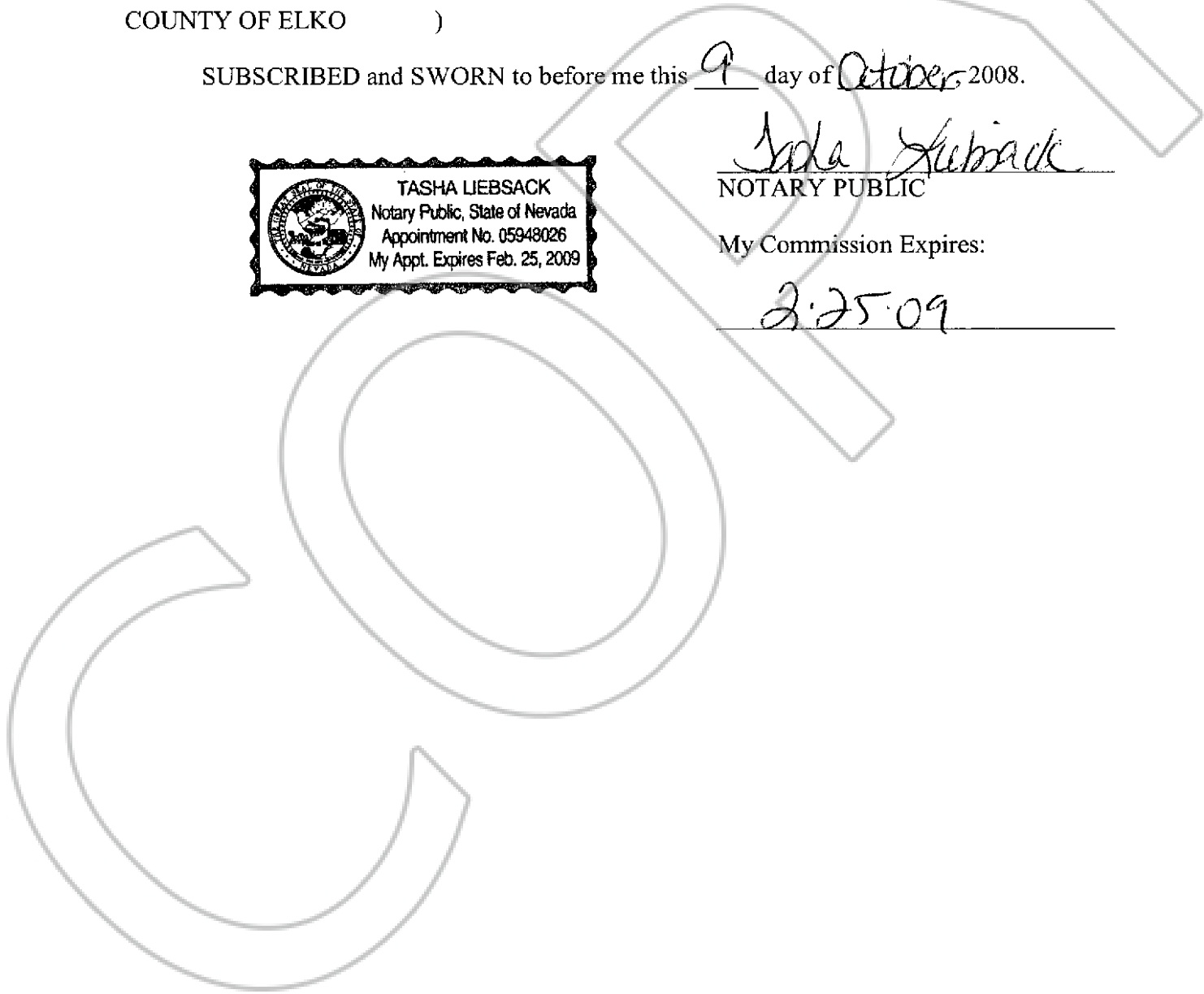
