
Robert Brock, being duly sworn, says:

Being duly authorized, I make this affidavit on behalf of Cortez Joint Venture, HC 66 Box 1250, Crescent Valley, NV 89821.

1. Pursuant to the provisions of 30 U.S.C. §§ 28f-k and 43 C.F.R. §§ 3834.10 to -23, a claim maintenance fee of \$125.00 is to be paid to the Bureau of Land Management for each non-exempt mining claim, mill site, or tunnel site for the assessment year ending September 1, 2008, in lieu of the requirement to perform and record affidavits of proof of annual assessment work for mining claims and to record a notice of intent to hold mill sites under 30 U.S.C. §§ 28-28e and 43 U.S.C. § 1744.
