## SPECIAL POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS THAT effective as of September 17th, 2008, I, Scott D. Williams as Vice President of M&I Marshall & Ilsley Bank, a Wisconsin corporation ("M&I Bank") and a duly authorized officer of M&I Bank's current affiliate entities including M&I Corp.
