**SPECIAL WARRANTY DEED CONVEYING  
AN INTEREST IN OVERRIDING ROYALTY**

This Royalty Deed (this "Deed") is made and effective as of the 28 day of July, 2005, by Juliet R. Wilson, an unmarried woman who holds the property to be conveyed, and whose address is 737 Wilson Court, Grand Junction, CO 81505 ("Grantor") and International Royalty Corporation, whose address is 10 Inverness Drive East, Suite 104, Englewood, CO 80112 ("Grantee").

**I. RECITALS AND DEFINED TERMS**

For and in consideration of Ten or more dollars and other good and valuable consideration received from Grantee, the receipt and sufficiency of which is acknowledge by Grantor, Grantor hereby bargains, sells, deeds and conveys to Grantee, its successors and assigns, all of the rights, titles and interests of Grantor in and under the Royalty Interests. This Deed also conveys any rights which Grantor may hold to receive royalty interests in mining claims which might be acquired subject to area of interest provisions which may pertain to the Royalty Interests by virtue of the various deeds, assignments, conveyances and agreements listed above. This Deed shall also convey to the Grantee any rights to after-acquired title to the Royalty Interests which may be obtained or held by Grantor.

## **III. MISCELLANEOUS**

Grantor warrants title to the rights, titles and interests conveyed to Grantee by this Deed against, but only against, any person or entity lawfully claiming the whole or any part thereof by, through or under Grantor, but not otherwise.

Grantor agrees to execute such other documents and give such further assurances, if any become necessary, in order to effectuate and carry out the full intents and purposes of this Deed.

The provisions of this Deed shall be binding upon and shall inure to the benefit of Grantor and Grantee and their respective successors, assigns, personal representatives and heirs.






