MODIFICATION TO DEED OF TRUST, SECURITY AGREEMENT, FINANCING STATEMENT, FIXTURE FILING AND ASSIGNMENT OF PRODUCTION

THIS MODIFICATION TO DEED OF TRUST. SECURITY AGREEMENT. FINANCING STATEMENT, FIXTURE FILING AND ASSIGNMENT OF PRODUCTION ("Modification"), is made as of November 28, 2008, between Energy Operations Nevada, LP ("Grantor") and Passport Management, LLC (the "Beneficiary").

Factual Background

- Grantor executed that certain Deed of Trust, Security Agreement, Financing Statement, Fixture Filing and Assignment of Production dated as of March 3, 2008, in favor of Beneficiary, which was recorded on May 23, 2008, with the Recorder of Eureka County, Nevada. as Document No. 0211869 (the "Deed of Trust"). Capitalized terms used herein and not otherwise defined have the meanings set forth in the Deed of Trust.
- B. The Deed of Trust secures, among other things, certain Obligations pursuant to the terms of a Note and Warrant Purchase Agreement dated as of March 3, 2008 (the "Purchase Agreement") among Terralliance Technologies, Inc., a Delaware corporation ("TTI"), the purchasers party thereto, (the "Purchasers") and Beneficiary, as Collateral Agent.
- TTI, Beneficiary and the Initial Purchasers and the Add-On Purchaser (as defined C. in the Purchase Agreement Amendment) are amending the Purchase Agreement to provide, among other things, for the issuance of an additional \$7,764,705 in aggregate principal amount of Notes pursuant to Amendment No. 1 to Note and Warrant Purchase Agreement of even date herewith (the "Purchase Agreement Amendment"). Grantor and Beneficiary are entering into this amendment to the Deed of Trust to increase the amount of the maximum indebtedness secured by the Deed of Trust and to confirm that the Deed of Trust secures, among other things, the Purchase Agreement, as amended by the Purchase Agreement Amendment, and the obligations under the Notes, as defined in the Purchase Agreement Amendment.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

- 1. All references in the Deed of Trust to the Purchase Agreement shall mean the Purchase Agreement as amended by the Purchase Agreement Amendment.
- 2. The definition of "Obligations" in Section 1.9 of the Deed of Trust is hereby amended by restating subsection (a) in its entirety as follows:
- (a) the \$150,000,000 principal amount and all other indebtedness evidenced the Initial Notes (as defined in the Purchase Agreement Amendment) and the \$7,764,705 aggregate principal amount and all other indebtedness evidenced by the Add-On Notes;
- 3. Section 2.3 of the Deed of Trust is hereby amended to increase the maximum amount of principal secured by the Deed of Trust from One Hundred Fifty Million Dollars (\$150,000,000) to One Hundred Fifty-Seven Million Seven Hundred Sixty-Four Thousand Seven Hundred Five Dollars (\$157,764,705).
- 4. Grantor and Beneficiary ratify and confirm the Deed of Trust, as modified hereby, in all respects, including the liens and security interests created thereby.
- 5. This Modification may be executed in counterparts, each of which shall be deemed an original but all of which shall constitute one and the same instrument.
- 6. Save and except as modified hereby, the Deed of Trust remains unmodified and in full force and effect.
