## **GRANT OF EASEMENT**

THIS GRANT OF EASEMENT is by and between Elko Land and Livestock Company, a Nevada corporation, "Grantor", and Paiute Pipeline Company, a Nevada corporation, "Grantee";

For good and valuable consideration, the undersigned Grantor hereby grants to Grantee, its successors and assigns, the nonexclusive right for the installation, operation, inspection, maintenance, replacement and removal of a gas pipeline or pipelines and appurtenances, ("Pipeline Facilities"), together with an easement therefore and the right of ingress thereto and egress therefrom, across, upon, in and under the following described real property in the County of Eureka, State of Nevada:

See Exhibit "A" and "B" attached hereto and made a part of this Grant of Easement;

Grantee, its successors and assigns, shall indemnify and hold harmless Grantor, its officers, directors, employees, stockholders, successors and assigns, from and against any and all losses, costs (including without limitation attorney's fees), damages, expenses, liability, claims, awards, demands, causes of action, and judgments for injury to, or death of, persons, and damage to, or loss or destruction of property caused by or resulting from the construction, maintenance, operation or repair of the Pipeline Facilities or the exercise by Grantee, its employees or agents, of any other rights herein set forth. This indemnity by Grantee shall not apply to injuries, deaths or damages caused by or resulting from the negligence, omissions or willful misconduct of Grantor, its employees, contractors or agents or by other Grantees.

Grantee, its successors and assigns, shall comply with all applicable laws, statutes, ordinances, rules, regulations and orders in exercising the rights set forth herein.

Grantor, its successors or assigns, shall not place any trees in the easement area, nor erect, install or construct any building, structure, or landscaping that, in the reasonable judgment and prior consent of Grantee, is inconsistent with Grantee's use of the easement.

Grantor makes no warranty or representation as to suitability of Subject Land for Grantee's easement use or purpose. Grantor makes no warranty or representation as to zoning, permitting or other legal requirements which may affect the grant of easement and Grantees use thereof. Grantee makes no warranty or representation as to the rights, purported rights or claims of third parties in the subject lands or affecting Grantee's use of the easement. Grantee

understands that this grant of easement is expressly subject to all prior rights of third parties of which Grantee has actual or constructive notice.

Grantee shall not make modifications or improvements to the existing access road except to maintain or restore it to its condition as of the date of this grant of easement, without the prior written consent of the Grantor, which will not be unreasonably conditioned, delayed or withheld.

Grantee shall have and hold the rights granted herein for so long as it uses and maintains the Pipeline Facilities on the lands described, and the rights granted herein shall be deemed to be abandoned and shall terminate upon Grantee's discontinuance of such use and maintenance for a period of one year and all such shall revert to Grantor, its successors or assigns.
