Notice and Affidavit of Fraudulent Deeds

I did not fill out these deeds and did not authorize these deeds.



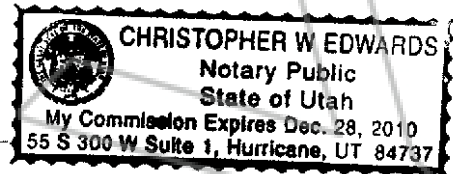
