SECOND MODIFICATION TO DEED OF TRUST, SECURITY AGREEMENT, FINANCING STATEMENT, FIXTURE FILING AND ASSIGNMENT OF PRODUCTION

THIS SECOND MODIFICATION TO DEED OF TRUST, SECURITY AGREEMENT, FINANCING STATEMENT, FIXTURE FILING AND ASSIGNMENT OF PRODUCTION ("Modification"), is made as of May 13, 2009, between Energy Operations Nevada, LP, a Nevada limited partnership ("Grantor"), and Passport Management, LLC, a Delaware limited liability company (the "Beneficiary").

- A.
