SECOND MODIFICATION TO DEED OF TRUST, SECURITY AGREEMENT,
FINANCING STATEMENT, FIXTURE FILING
AND ASSIGNMENT OF PRODUCTION

THIS SECOND MODIFICATION TO DEED OF TRUST, SECURITY AGREEMENT,
FINANCING STATEMENT, FIXTURE FILING AND ASSIGNMENT OF PRODUCTION
("Modification"), is made as of May 13, 2009, between Great Nevada Petroleum, LLC, a Nevada
limited liability company ("Grantor"), and Passport Management, LLC, a Delaware limited
liability company (the "Beneficiary").

Factual Background

A. Grantor executed that certain Deed of Trust, Security Agreement, Financing
Statement, Fixture Filing and Assignment of Production dated as of March 3, 2008, in favor of
Beneficiary, which was recorded on May 23, 2008, with the Recorder of Eureka County, Nevada,
as Document No. 0211870, as modified by a Modification recorded on December 31, 2008 as
Document No. 0213001 (the "Deed of Trust"). Capitalized terms used herein and not otherwise
defined have the meanings set forth in the Deed of Trust.

B. The Deed of Trust secures, among other things, certain Obligations pursuant to
the terms of a Note and Warrant Purchase Agreement dated as of March 3, 2008 as amended by
Amendment No. 1 to Note and Warrant Purchase Agreement dated as of November 28, 2008 and
as amended by that certain Amendment No. 2 to Note and Warrant Purchase Agreement dated as
of January 7, 2009 (the "Purchase Agreement") by and among Terralliance Technologies, Inc., a
Delaware corporation ("TTI"), those certain purchasers party thereto (the "Purchasers") and
Beneficiary, as Collateral Agent.

C. TTI, Beneficiary and the Purchasers are amending and restating the Purchase
Agreement.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which are
hereby acknowledged, the parties agree as follows:

1. All references in the Deed of Trust to the Purchase Agreement shall mean the Amended and Restated Purchase Agreement among TTI, Beneficiary and the Purchasers dated as of May 13, 2009 as the same may be renewed, extended, modified, supplemented or amended from time to time.

2. Grantor and Beneficiary ratify and confirm the Deed of Trust, as modified hereby, in all respects, including the liens and security interests created thereby.

3. This Modification may be executed in counterparts, each of which shall be deemed an original but all of which shall constitute one and the same instrument.

4. Save and except as modified hereby, the Deed of Trust remains unmodified and in full force and effect.

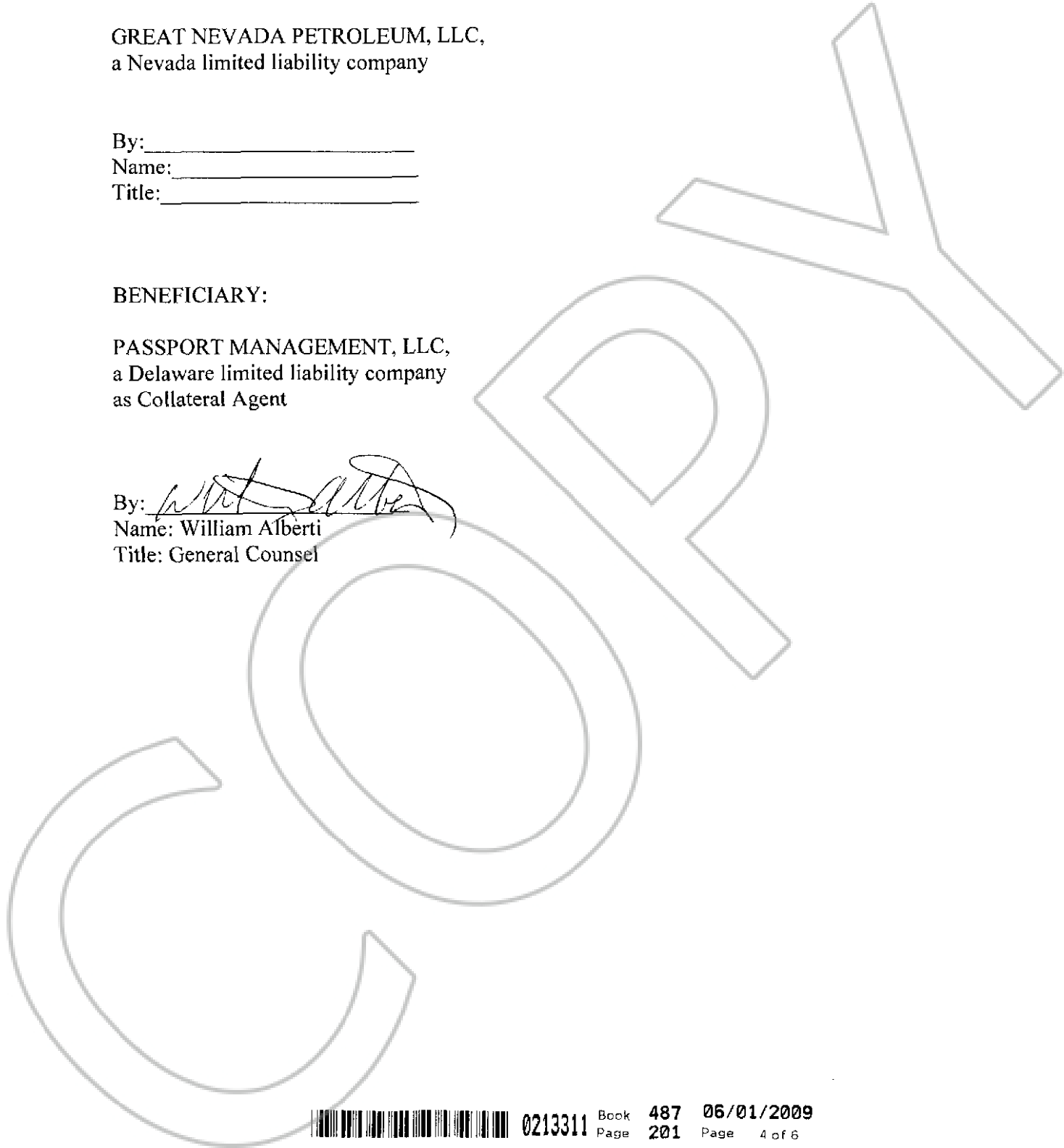
