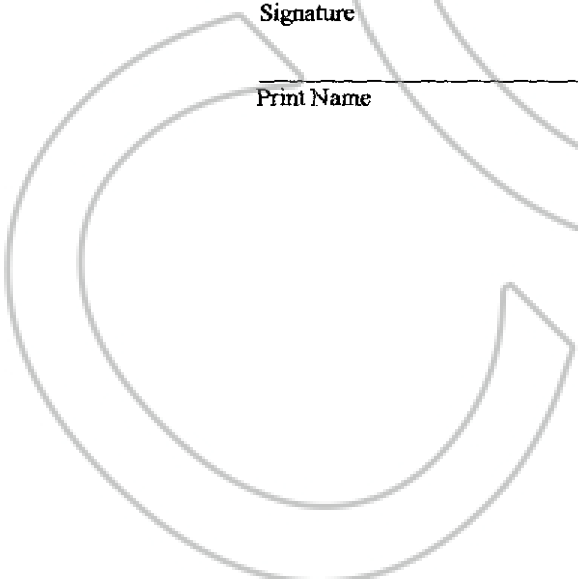

**TERMINATION AND RECONVEYANCE OF PRODUCTION PAYMENT**

WHEREAS, Blackburn Oil & Gas, LLC ("Blackburn") and BlueRock Energy Capital, Ltd. ("BlueRock") are parties to a Conveyance of Production Payment dated effective as of February 1, 2007, recorded at Volume 455, Page 375, Official Records of Eureka County, Nevada; as amended by First Amendment to Conveyance of Production Payment dated effective as of February 1, 2007, recorded at Volume 461, Page 135, Official Records of Eureka County, Nevada; (hereinafter referred to as the "Conveyance"); and

WHEREAS, Blackburn and BlueRock are also parties to that corresponding unrecorded Production Agreement dated effective as of February 1, 2007, as amended by First Amendment of Production Agreement dated effective as of February 1, 2007 (collectively, the "Production Agreement"); and

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, BlueRock has RELEASED, DISCHARGED and TERMINATED, and by these presents does hereby RELEASE, DISCHARGE and TERMINATE without warranty, representation or recourse, either express or implied, the Conveyance and the Production Agreement, and BlueRock hereby RECONVEYS to Blackburn the Production Payment covered by the Conveyance and the Production Agreement.

IN WITNESS WHEREOF, this instrument is executed this 24<sup>th</sup> day of May, 2009, but shall be effective as of May 1, 2009. All Production Payment revenues attributable to the months prior to May 1, 2009 and received by BlueRock after May 1, 2009 shall belong to BlueRock. 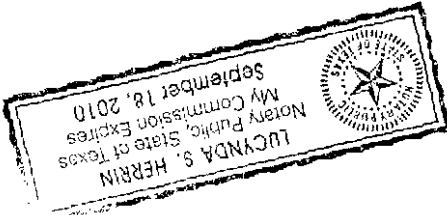

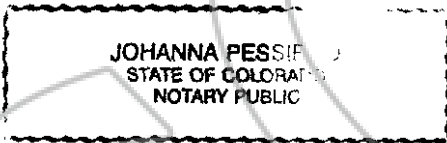
